

**Darke County LEPC Minutes
September 18, 2007**

This meeting of the Board Members of the Darke County LEPC was called to order at The OSU Extension Office at 10:03 am by Chairman Mike Rhoades. Mindy Saylor took roll call. The minutes of June 19, 2007 and July 17, 2007 organizational meeting were presented for review. Tim Gade made a motion to accept both minutes, Bob Dietrich 2nd the motion, all in favor, motion passed, minutes accepted.

Treasurer's report:

- In Treasurer Mark Wolf absence Mindy Saylor presented this report. Balance as of August 31, 2007 was \$59,470.66. YTD expenses of \$23,177.83 and receipts are \$41,705.28. Each member was given a detailed print out of the LEPC fund. Jim Schaar made a motion to accept the treasurer's report, Tim Gade 2nd that motion, all in favor, motion passed, and Treasurer's report accepted.

Coordinator's report:

- June, Mindy and Melody have all completed the ICS 300 & 400 classes. These are a requirement in the NIMS system.
- The HMEP Planning Funds have been received in the amount of \$2,856.00.
